There has been an approach suggested where we tentatively accept bookings starting July 1 with an agreement to fully commit at least three months out so that the races can confidently open registration. Of course, even that commitment would be contingent on state/local guidance and permitting and I can see that the contract is worded that way.

- Discussed comfort level of starting finish line services July 1st.
- Concerned about where things would be in terms of races, as well as having enough members vaccinated.
- While there is lots of uncertainty, we decided to start accepting bookings starting July 1st.
- The commitment would be three months out and would be contingent on state / local guidance and permitting.
